Official Contest Rules

The contest begins September 1, 2017 and ends on October 31, 2017. When you receive an approved & funded auto loan from the credit union during this period, you will automatically be entered into a drawing for a 55" Flat Screen TV. All auto loans are subject to credit approval.
4. **Eligibility Requirement:** New members must meet eligibility requirements of Piedmont Plus Federal Credit Union. Existing Piedmont Plus Federal Credit Union auto loans do not qualify for contest drawing.
5. **Drawing:** A random drawing will be held by Piedmont Plus Federal Credit Union following the end of the contest on October 31, 2017. Winner need not be present to win. The credit union will notify the winner by phone and/or mail.
6. **Eligibility Exceptions and General Terms:** Any member of the credit union in good standing is eligible. Contest void where prohibited or restricted by law. Federal, state and local taxes are the sole responsibility of the prize winner. Contest subject to all applicable federal, state and local laws and regulations. No substitutions or transfers of prize permitted except at the sole discretion of the sponsor.
7. **Entrants Agreement:** By participating, entrants agree to these official rules and accept decisions by Piedmont Plus Federal Credit Union as final. Entrants also agree to the use of their name and photograph in any Credit Union publication or web site if chosen to be the winner.

The winner must return the Affidavit to the credit union within 14 days after prize notification or prize will be forfeited and awarded to an alternate winner. The prize winner may not transfer their prize to any other party prior to acceptance.
